

Radiative transport in the delta- P_1 approximation: accuracy of fluence rate and optical penetration depth predictions in turbid semi-infinite media

Abstract. Using the δ - P_1 approximation to the Boltzmann transport equation we develop analytic solutions for the fluence rate produced by planar (1-D) and Gaussian beam (2-D) irradiation of a homogeneous, turbid, semi-infinite medium. To assess the performance of these solutions we compare the predictions for the fluence rate and two metrics of the optical penetration depth with Monte Carlo simulations. We provide results under both refractive-index matched and mismatched conditions for optical properties where the ratio of reduced scattering to absorption lies in the range $0 \leq (\mu'_s/\mu_a) \leq 10^4$. For planar irradiation, the δ - P_1 approximation provides fluence rate profiles accurate to $\pm 16\%$ for depths up to six transport mean free paths (l^*) over the full range of optical properties. Metrics for optical penetration depth are predicted with an accuracy of $\pm 4\%$. For Gaussian irradiation using beam radii $r_0 \geq 3l^*$, the accuracy of the fluence rate predictions is no worse than in the planar irradiation case. For smaller beam radii, the predictions degrade significantly. Specifically for media with $(\mu'_s/\mu_a) = 1$ irradiated with a beam radius of $r_0 = l^*$, the error in the fluence rate approaches 100%. Nevertheless, the accuracy of the optical penetration depth predictions remains excellent for Gaussian beam irradiation, and degrades to only $\pm 20\%$ for $r_0 = l^*$. These results show that for a given set of optical properties (μ'_s/μ_a) , the optical penetration depth decreases with a reduction in the beam diameter. Graphs are provided to indicate the optical and geometrical conditions under which one must replace the δ - P_1 results for planar irradiation with those for Gaussian beam irradiation to maintain accurate dosimetry predictions. © 2004 Society of Photo-Optical Instrumentation Engineers. 1 Introduction

Many biophotonics applications require knowledge of the light distribution produced by illumination of a turbid tissue with a collimated laser beam.¹ Examples include photodynamic therapy, photon migration spectroscopy, and optoacoustic imaging. If one considers light propagating as a neutral particle, the Boltzmann transport equation provides an exact description of radiative transport.² However, the Boltzmann transport equation is an integrodifferential equation that often cannot be solved analytically. As an alternative, investigators have resorted to a variety of analytic and computational methods, including Monte Carlo simulations, the adding-doubling method, and functional expansion methods.^{2–6} Each of these methods possesses unique limitations. For example, while Monte Carlo simulations provide solutions to the Boltzmann transport equation that are exact within statistical un-

certainty, they require significant computational resources.^{7–9} While, numerical finite difference or finite element solutions for the Boltzmann transport equation¹⁰ may involve less computational expenditure, they require spatial and angular discretizations of the computational domain that lead to inaccuracies that are often difficult to quantify. Finally functional expansion methods, such as the standard diffusion approximation (SDA), that express the angular distribution of the light field and the single-scattering-phase function as a truncated series of spherical harmonics are typically accurate only under a limiting set of conditions.^{2,6,11–13}

Although the SDA provides only an approximate solution to the Boltzmann transport equation, its computational simplicity has proven valuable for applications in optical diagnostics and therapeutics. Unfortunately, the limitations of the SDA are significant and confine its applicability to highly scattering media and to locations distal from both collimated sources and interfaces possessing significant mismatches in

refractive index.^{11,14–16} Such conditions are not satisfied in many biomedical laser applications and, over the past 15 yr, hybrid Monte Carlo–diffusion methods^{17,18} as well as the δ - P_1 , P_3 , and δ - P_3 approximations have been proposed as improved radiative transport models.^{1,6,19–25} Our focus here is the δ - P_1 (or δ -Eddington) model first introduced in 1976 by Joseph et al.²⁶ and first applied to problems in the biomedical arena independently by Prahl,^{23,27} by Star,^{6,24} and Star et al.²⁵

Many investigators in biomedical optics have studied the accuracy of functional expansion methods. Groenhuis et al. provided one of the first comparative studies between Monte Carlo and SDA predictions for the spatially resolved diffuse reflectance produced by illumination of a turbid medium with a finite diameter laser beam.¹¹ Later, Flock et al. provided another comparison between Monte Carlo simulations and the SDA that focused primarily on optical dosimetry; specifically the accuracy of fluence rate profiles and optical penetration depth predictions for planar irradiation of a turbid medium.²⁸ More recently, Venugopalan et al. presented analytic solutions for radiative transport within the δ - P_1 approximation for infinite media illuminated with a finite spherical source.¹⁹ The accuracy of these solutions was demonstrated by comparison with experimental measurements made in phantoms over a broad range of optical properties. Spott and Svaasand reviewed a number of formulations of the diffusion approximation (P_1 , δ - P_1 , δ - P_3) for a semi-infinite medium illuminated with a collimated light source, and compared fluence rate and diffuse reflectance predictions with Monte Carlo simulations for optical properties representative of *in vivo* conditions.¹⁶ Dickey et al.^{20,21} as well as Hull and Foster²² have studied the improvements in accuracy offered by the P_3 approximation for predicting both fluence rate profiles and spatially resolved diffuse reflectance. These studies have confirmed that the δ - P_1 approach can provide significant improvements in radiative transport predictions relative to SDA with minimal additional complexity.

While these investigations have provided some indication of the improved accuracy provided by the δ - P_1 approximation relative to the SDA, none have offered a quantitative assessment of its performance against a radiative transport benchmark such as Monte Carlo simulations over a wide range of optical properties. Thus, it is difficult to establish *a priori* the loss of accuracy that one suffers when using the δ - P_1 approximation to determine fluence rate distributions or optical penetration depths. Our objective is to provide a comprehensive quantitative assessment of the accuracy of optical dosimetry predictions provided by the δ - P_1 approximation when a turbid semi-infinite medium is exposed to collimated radiation. Here, we report on the variation of the δ - P_1 model accuracy with tissue optical properties and diameter of the incident laser beam.

Specifically, we determined the fluence rate profiles predicted by the δ - P_1 approximation for semi-infinite media when subjected to planar (1-D) or Gaussian beam (2-D) irradiation. For comparison, we performed Monte Carlo simulations to provide “benchmark” solutions of the Boltzmann transport equation for multiple sets of optical properties. While we include plots of diffuse reflectance R_d versus (μ'_s/μ_a) for planar irradiation, our focus is on the internal light distribution as represented by the spatial variation of the

fluence rate. Since it is cumbersome to display the variation of fluence rate with depth for more than a few sets of optical properties, we also examined predictions for the optical penetration depth. Comparison of the optical penetration depths predicted by the δ - P_1 approximation with those derived from Monte Carlo simulations enables a continuous assessment of the δ - P_1 model accuracy over a broad range of optical properties. These results are presented within a dimensionless framework to enable rapid estimation of the light distribution in a medium of known optical properties. Moreover, to provide quantitative error assessment, we include plots of the difference between the δ - P_1 and Monte Carlo estimates. The variation of these errors with tissue optical properties and irradiation conditions provide much insight into the nature and origin of the deficiencies inherent in the δ - P_1 approximation as well as other functional expansion methods.

2 δ - P_1 Model Formulation and Monte Carlo Computation

2.1 δ - P_1 Approximation of the Single-Scattering Phase Function

The basis of the δ - P_1 approximation to radiative transport is the δ - P_1 phase function as formulated by Joseph et al.²⁶

$$p_{\delta-P_1}(\hat{\omega} \cdot \hat{\omega}') = \frac{1}{4\pi} \{ 2f\delta[1 - (\hat{\omega} \cdot \hat{\omega}')] + (1-f)[1 + 3g^*(\hat{\omega} \cdot \hat{\omega}')] \}, \quad (1)$$

where $\hat{\omega}$ and $\hat{\omega}'$ are unit vectors that represent the direction of light propagation before and after scattering, respectively. In Eq. (1) f is the fraction of light scattered directly forward, which the δ - P_1 model treats as unscattered light. The remainder of the light $(1-f)$ is diffusely scattered according to a standard P_1 (or Eddington) phase function with single scattering asymmetry g^* . To determine appropriate values for f and g^* , one must choose a phase function to approximate. In this paper, we choose to provide results for the Henyey-Greenstein phase function, as it is known to provide a reasonable approximation for the optical scattering in biological tissues²⁹:

$$p_{\text{HG}}(\hat{\omega} \cdot \hat{\omega}') = \frac{1}{4\pi} \frac{1 - g_1^2}{[1 - 2g_1(\hat{\omega} \cdot \hat{\omega}') + g_1^2]^{3/2}}. \quad (2)$$

Recalling that for a spatially isotropic medium, the n^{th} moment, g_n , of the phase function $p(\hat{\omega} \cdot \hat{\omega}')$ is defined by

$$g_n = 2\pi \int_{-1}^1 P_n(\hat{\omega} \cdot \hat{\omega}') p(\hat{\omega} \cdot \hat{\omega}') d(\hat{\omega} \cdot \hat{\omega}'), \quad (3)$$

where P_n is the n^{th} Legendre polynomial, we determine f and g^* by requiring the first two moments of the δ - P_1 phase function, $g_1 = f + (1-f)g^*$ and $g_2 = f$, to match the corresponding moments of the Henyey-Greenstein phase function, which are given by $g_n = g_1^n$. This yields the following expressions for f and g^* :

$$f = g_1^2 \quad \text{and} \quad g^* = g_1 / (g_1 + 1). \quad (4)$$

For simplicity, from this point forward we refer to g_1 simply as g and all δ - P_1 model results in this paper are shown for $g=0.9$ unless noted otherwise.

2.2 δ - P_1 Approximation of the Radiance

In a manner similar to the phase function, the radiance is also separated into collimated and diffuse components:

$$L(\mathbf{r}, \hat{\omega}) = L_c(\mathbf{r}, \hat{\omega}) + L_d(\mathbf{r}, \hat{\omega}), \quad (5)$$

where \mathbf{r} is the position vector and $\hat{\omega}$ is a unit vector representing the direction of light propagation.

For irradiation with a collimated laser beam normally incident on the surface of a semi-infinite medium, the collimated radiance takes the form

$$L_c(\mathbf{r}, \hat{\omega}) = \frac{1}{2\pi} E(\mathbf{r}, \hat{z}) \delta(1 - \hat{\omega} \cdot \hat{z}), \quad (6)$$

where \hat{z} is the direction of the collimated light within the medium, and $E(\mathbf{r}, \hat{z})$ is the complete spatial distribution of collimated light provided by the source. While the lateral spatial variation of $E(\mathbf{r}, \hat{z})$ is given by the irradiance distribution of the incident laser beam $E_0(x, y)$, its decay with depth (z -dir) is governed by absorption and scattering within the medium. Specifically, loss of collimated light arises from both absorption and diffuse scattering. Noting that in the δ - P_1 phase function only $(1-f)$ of the incident light is diffusely scattered, the decay of the collimated light with depth will behave as a modified Beer-Lambert law:

$$\begin{aligned} E(\mathbf{r}, \hat{z}) &= E_0(x, y)(1 - R_s) \exp\{-[\mu_a + \mu_s(1-f)]z\} \\ &= E_0(x, y)(1 - R_s) \exp[-(\mu_a + \mu_s^*)z], \end{aligned} \quad (7)$$

where R_s is the specular reflectance for unpolarized light, μ_a is the absorption coefficient, μ_s is the scattering coefficient, and $\mu_s^* \equiv \mu_s(1-f)$ is a reduced scattering coefficient. For a collimated beam traveling along the z axis that possesses either a uniform or Gaussian irradiance profile we can work in cylindrical (r, z) rather than Cartesian (x, y, z) coordinates. In this case, the collimated fluence rate is given by

$$\varphi_c(\mathbf{r}) = \int_{4\pi} L_c(\mathbf{r}, \hat{\omega}) = E(\mathbf{r}, \hat{z}) = E_0(r)(1 - R_s) \exp(-\mu_t^* z), \quad (8)$$

where $E_0(r)$ is the radial irradiance distribution of the incident laser beam and $\mu_t^* \equiv \mu_a + \mu_s^*$.

The diffuse radiance in Eq. (5) is approximated, as in the SDA, by the sum of the first two terms in a Legendre polynomial series expansion:

$$\begin{aligned} L_d(\mathbf{r}, \hat{\omega}) &= \frac{1}{4\pi} \int_{4\pi} L_d(\mathbf{r}, \hat{\omega}') d\Omega' \\ &\quad + \frac{3}{4\pi} \int_{4\pi} L_d(\mathbf{r}, \hat{\omega}') (\hat{\omega}' \cdot \hat{\omega}) d\Omega' \\ &= \frac{1}{4\pi} \varphi_d(\mathbf{r}) + \frac{3}{4\pi} \mathbf{j}(\mathbf{r}) \cdot \hat{\omega} \end{aligned} \quad (9)$$

where $\varphi_d(\mathbf{r})$ is the diffuse fluence rate and $\mathbf{j}(\mathbf{r})$ is the radiant flux.

The improved accuracy offered by the δ - P_1 approximation stems from the addition of the Dirac δ function to both the single scattering phase function and the radiance approximation. The δ function provides an additional degree of freedom well suited to accommodate collimated sources and highly forward-scattering media. Thus the addition of the δ function relieves substantially the degree of asymmetry that must be provided by the first-order term in the Legendre expansion.⁶

2.3 Governing Equations and Boundary Conditions

Substituting Eqs. (1), (6), and (9) into the Boltzmann transport equation and performing balances in both the fluence rate and the radiant flux provides the governing equations in the δ - P_1 approximation for a semi-infinite medium¹⁹:

$$\begin{aligned} \nabla^2 \varphi_d(\mathbf{r}) - \mu_{\text{eff}}^2 \varphi_d(\mathbf{r}) &= -3\mu_s^* \mu_{\text{tr}} E(\mathbf{r}, \hat{z}) \\ &\quad + 3g^* \mu_s^* \nabla E(\mathbf{r}, \hat{z}) \cdot \hat{z}, \end{aligned} \quad (10)$$

$$\mathbf{j}(\mathbf{r}) = -\frac{1}{3\mu_{\text{tr}}} [\nabla \varphi_d(\mathbf{r}) - 3g^* \mu_s^* E(\mathbf{r}, \hat{z}) \hat{z}], \quad (11)$$

where $\mu_s' \equiv \mu_s(1-g)$ is the isotropic scattering coefficient, $\mu_{\text{tr}} \equiv (\mu_a + \mu_s')$ is the transport coefficient, and $\mu_{\text{eff}} \equiv (3\mu_a \mu_{\text{tr}})^{1/2}$ is the effective attenuation coefficient.

Two boundary conditions are required to solve Eqs. (10) and (11). At the free surface of the medium, we require conservation of the diffuse flux component normal to the interface, which yields

$$[\varphi_d(\mathbf{r}) - Ah \nabla \varphi_d(\mathbf{r}) \cdot \hat{z}]|_{z=0} = -3Ahg^* \mu_s^* E(\mathbf{r}, \hat{z})|_{z=0}, \quad (12)$$

where $A = (1 + R_2)/(1 - R_1)$ and $h = 2/3\mu_{\text{tr}}$. Here R_1 and R_2 are the first and second moments of the Fresnel reflection coefficient for unpolarized light and are given by

$$R_1 = 2 \int_0^1 r_F(\nu) \nu d\nu \quad \text{and} \quad R_2 = 3 \int_0^1 r_F(\nu) \nu^2 d\nu, \quad (13)$$

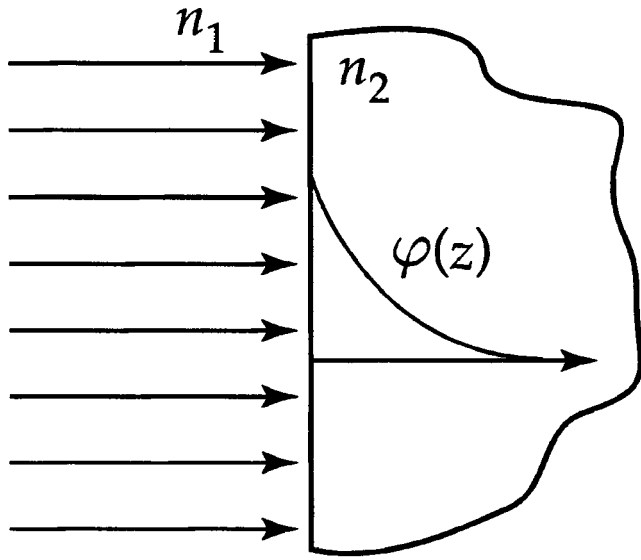
where $\nu = \hat{\omega} \cdot \hat{z}$, with \hat{z} defined as the inward pointing unit vector normal to the surface. The details of this derivation are provided in Appendix A. Note that Eq. (12) represents an exact formulation for conservation of energy at the boundary and avoids the approximations inherent in the use of extrapolated boundary conditions.^{30,31} The second boundary condition requires the diffuse light field to vanish in regions far away from the source. Thus,

$$\varphi_d(\mathbf{r})|_{r \rightarrow \infty} \rightarrow 0. \quad (14)$$

2.4 Solutions for Planar and Gaussian Beam Irradiation

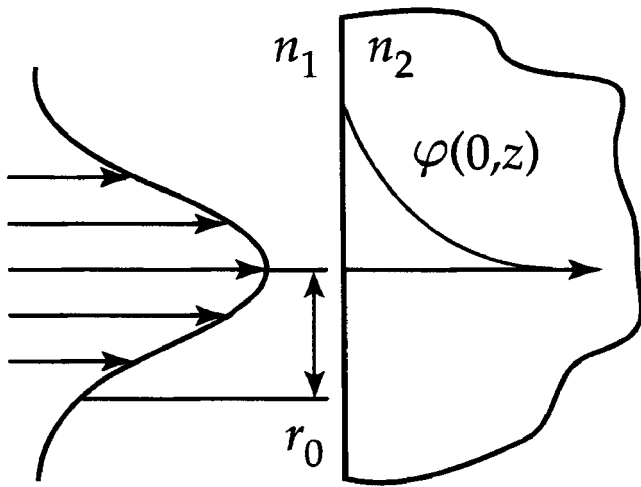
The total fluence rate is given by the sum of the collimated and diffuse fluence rates:

$$\varphi(\mathbf{r}) = \varphi_c(\mathbf{r}) + \varphi_d(\mathbf{r}). \quad (15)$$

2.4.1 Collimated fluence rate

For either planar or Gaussian beam irradiation conditions, as shown in Fig. 1, the collimated fluence rate within the tissue is expressed in the form

$$\varphi_c(r, z) = E_0(r)(1 - R_s)\exp(-\mu_t^* z). \quad (16)$$

For planar irradiation, $E_0(r) = E_0$ while for Gaussian beam irradiation, $E_0(r) = E_0 \exp(-2r^2/r_0^2)$, where r_0 is the Gauss-

ian beam radius, i.e., the radial location where the irradiance falls is $1/e^2$ of the maximum irradiance. Note that $E_0 = 2P/\pi r_0^2$, where E_0 denotes the peak irradiance and P is the incident power of the Gaussian laser beam. For generality, we define a normalized collimated fluence rate $\bar{\varphi}_c$ as

$$\bar{\varphi}_c = \frac{\varphi_c(r, z)}{E_0(r)(1 - R_s)} = \exp(-\mu_t^* z). \quad (17)$$

2.4.2 Diffuse fluence rate for planar irradiation

For planar illumination the diffuse fluence rate is determined by solving Eq. (10) subject to the boundary conditions Eqs. (12) and (14) and yields

$$\varphi_d(z) = E_0(1 - R_s)[\alpha \exp(-\mu_t^* z) + \beta \exp(-\mu_{\text{eff}}^* z)], \quad (18)$$

where

$$\alpha = \frac{3\mu_s^*(\mu_t^* + g^*\mu_a)}{\mu_{\text{eff}}^2 - \mu_t^{*2}}, \quad (19)$$

and

$$\beta = \frac{-\alpha(1 + Ah\mu_t^*) - 3Ahg^*\mu_s^*}{(1 + Ah\mu_{\text{eff}})}. \quad (20)$$

The solution procedure is detailed in Appendix B. In a manner analogous to the collimated fluence rate, we define a normalized diffuse fluence rate $\bar{\varphi}_d$ as

$$\bar{\varphi}_d(z) = \frac{\varphi_d(z)}{E_0(1 - R_s)} = \alpha \exp(-\mu_t^* z) + \beta \exp(-\mu_{\text{eff}}^* z). \quad (21)$$

2.4.3 Diffuse fluence rate for Gaussian beam irradiation

For Gaussian beam irradiation, the diffuse fluence rate is given by

$$\begin{aligned} \varphi_d(r, z) = E_0(1 - R_s) \int_0^\infty \{ & \gamma \exp(-\mu_t^* z) \\ & + \xi \exp[-(k^2 + \mu_{\text{eff}}^2)^{1/2} z] \} \mathcal{J}_0(kr) k dk, \end{aligned} \quad (22)$$

where

$$\gamma = \frac{3\mu_s^*(\mu_t^* + g^*\mu_a)r_0^2 \exp(-r_0^2 k^2/8)}{4(k^2 + \mu_{\text{eff}}^2 - \mu_t^{*2})}, \quad (23)$$

$$\xi = \frac{-3g^*\mu_s^*r_0^2 \exp(-r_0^2 k^2/8) - 4\gamma[(Ah)^{-1} + \mu_t^*]}{4[(Ah)^{-1} + (k^2 + \mu_{\text{eff}}^2)^{1/2}]}, \quad (24)$$

and \mathcal{J}_0 is the zeroth-order Bessel function of the first kind. The solution procedure is detailed in Appendix C. The normalized fluence rate for Gaussian beam irradiation is given by

$$\bar{\varphi}_d(r, z) = \int_0^\infty \{ \gamma \exp(-\mu_t^* z) + \xi \exp[-(k^2 + \mu_{\text{eff}}^2)^{1/2} z] \} \mathcal{J}_0(kr) k dk. \quad (25)$$

Numerical methods (MATLAB, MathWorks, Natick, Massachusetts) were employed to compute the definite integral in Eqs. (22) and (25).

2.5 Diffuse Reflectance for Planar Irradiation

The prediction of the diffuse reflectance provided by the δ - P_1 approximation is

$$R_d = \frac{-\mathbf{j}(z) \cdot \hat{z}}{E_0(1-R_s)} \Big|_{z=0} = \frac{1}{3\mu_{\text{tr}}E_0(1-R_s)} \left[3g^* \mu_s^* E_0 \exp(-\mu_t^* z) - \frac{d\varphi_d(z)}{dz} \right] \Big|_{z=0} = \frac{\bar{\varphi}_d(z)}{2A} \Big|_{z=0}. \quad (26)$$

2.6 Limiting Cases

A unique feature of the solutions provided by the δ - P_1 approximation is that $\varphi_d \rightarrow 0$ in the limit of vanishing scattering, i.e., when $\mu_s' \ll \mu_a$. Thus in a medium where absorption is dominant $\mu_t^* \rightarrow \mu_a$ and the total fluence rate is governed solely by the collimated contribution, i.e.,

$$\lim_{(\mu_s' / \mu_a) \rightarrow 0} \varphi(r, z) = \varphi_c(r, z) = E_0(r)(1-R_s)\exp(-\mu_a z). \quad (27)$$

Thus, unlike prevalent implementations of the SDA wherein the collimated light source is replaced by a point source placed at a depth $z = (1/\mu_s')$ within the medium, the δ - P_1 approximation correctly recovers Beer's law in the limit of no scattering.

For media in which scattering is dominant ($\mu_s' \gg \mu_a$ or $\mu_t^* \gg \mu_{\text{eff}}$), the total fluence rate resulting from planar irradiation reduces to

$$\lim_{(\mu_s' / \mu_a) \rightarrow \infty} \varphi(z) = E_0(1-R_s) [(3+2A)\exp(-\mu_{\text{eff}} z) - 2\exp(-\mu_t^* z)]. \quad (28)$$

If we further consider this fluence rate in the far field (large z), Eq. (28) reduces to

$$\lim_{(\mu_s' / \mu_a) \rightarrow \infty} \varphi(z) = E_0(1-R_s)(3+2A)\exp(-\mu_{\text{eff}} z) \quad \text{for large } z. \quad (29)$$

Equation (29) is equivalent to the fluence rate prediction given by the SDA.¹³ Thus, in the limit of high scattering, and away from boundaries and collimated sources, the solution provided by the δ - P_1 approximation properly reduces to that given by the SDA.

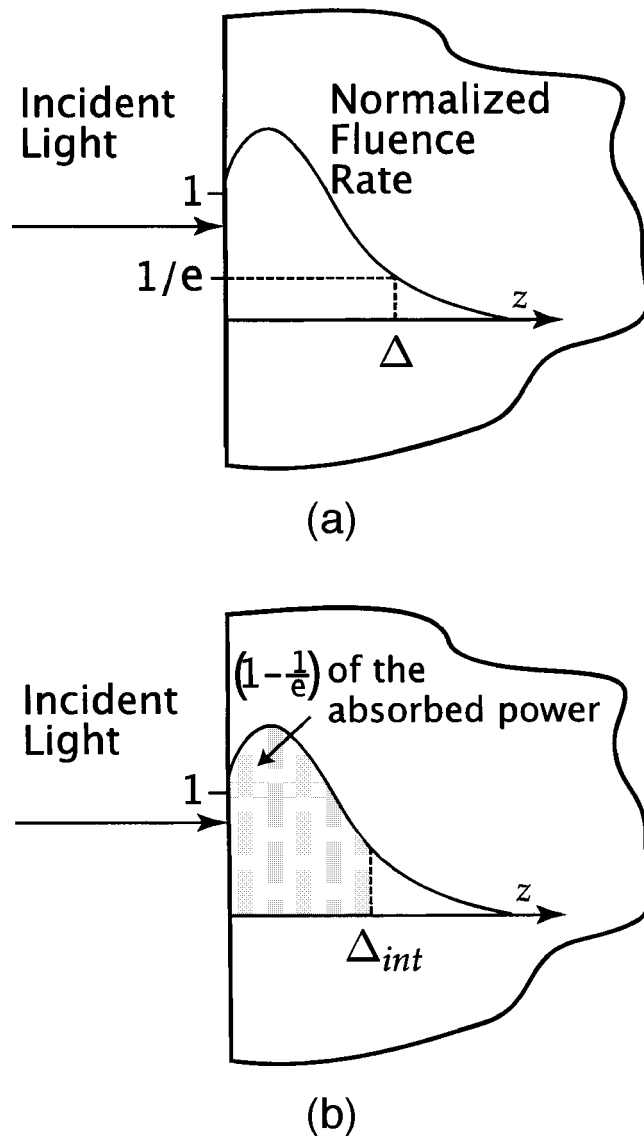


Fig. 2 Graphical depiction of optical penetration depths (a) Δ and (b) Δ_{int} .

2.7 Optical Penetration Depth

Apart from the fluence rate profiles and diffuse reflectance results offered by the δ - P_1 approximation, we are also interested in its predictions for the characteristic optical penetration depth (OPD) in the tissue. In Fig. 2, we display two variations of the OPD that we consider in this study. The first penetration depth metric Δ is simply the depth at which the fluence rate falls to $1/e$ of the incident fluence rate after accounting for losses due to specular reflection. The second penetration depth metric Δ_{int} is the depth at which all but $1/e$ of the power of the laser radiation has been absorbed after accounting for losses due to both specular and diffuse reflection. For generality, we normalize both these metrics relative to a characteristic length scale. We choose $(1/\mu_{\text{eff}})$ for this length scale as it is the traditional definition for the optical penetration depth³² and is the length scale over which the homogeneous solution to Eq. (10) decays. Accordingly we define

$$\bar{\Delta} \equiv \mu_{\text{eff}} \Delta \quad \text{and} \quad \bar{\Delta}_{\text{int}} \equiv \mu_{\text{eff}} \Delta_{\text{int}}. \quad (30)$$

2.8 Monte Carlo Simulations

We performed Monte Carlo simulations for planar and Gaussian beam irradiation of semi-infinite media under both refractive index matched and mismatched conditions. For this purpose we employed code derived from the Monte Carlo Multi-Layer (MCML) package written by Wang et al.^{8,9} that computes the 3-D fluence rate distribution and spatially resolved diffuse reflectance corresponding to irradiation with a laser beam possessing either uniform or Gaussian profiles. A Henyey-Greenstein phase function was utilized with a single scattering asymmetry coefficient of $g = 0.9$ unless stated otherwise. This value of g was chosen as it is representative of many biological tissues.²⁹ To approximate planar irradiation conditions we used a beam with a uniform irradiance profile with radius $r_0 = 200l^*$, where $l^* \equiv (1/\mu_{\text{tr}})$ is the transport mean free path. For Gaussian beam illumination, we set r_0 to the desired $1/e^2$ radius of the laser beam. To provide sufficient spatial resolution a minimum of 100 grid points were contained within one beam radius. Between 10^7 and 2×10^9 photons were launched for each simulation and resulted in fluence rate estimates with relative standard deviation of less than 0.1%.

3 Results and Discussion

3.1 Planar Illumination

Figures 3(a) and 3(b) provide normalized fluence rate profiles predicted by the δ - P_1 approximation and Monte Carlo simulations under planar illumination conditions for $0.3 \leq (\mu'_s/\mu_a) \leq 100$ and relative refractive indices $n = (n_2/n_1) = 1.0$ and 1.4, respectively. Note that the profiles are plotted against a reduced depth that is normalized relative to the transport mean free path l^* . These figures also provide the error of the δ - P_1 predictions relative to the Monte Carlo estimates.

Overall, the performance of the δ - P_1 approximation is impressive. The fluence rate is predicted with an error of $\leq 12\%$ over the full range of optical properties. In the far field, the model performance is exceptional for large (μ'_s/μ_a) , degrades slightly when scattering is comparable to absorption $(\mu'_s \approx \mu_a)$, and improves again when absorption dominates scattering $(\mu'_s/\mu_a \leq 0.3)$. This behavior is expected. For large (μ'_s/μ_a) the prevalence of multiple scattering enables the diffuse component of the δ - P_1 approximation to provide an accurate description of the light field. However, when scattering is still significant but (μ'_s/μ_a) is reduced, the decay of the light field occurs on a spatial scale intermediate to that predicted by diffusion, i.e., $\exp(-\mu_{\text{eff}}z)$, and that predicted by the total interaction coefficient, i.e., $\exp(-\mu_t^*z)$. This results in an error between the δ - P_1 model and the Monte Carlo estimates that increases with increasing depth. This is seen most notably for the case of $(\mu'_s/\mu_a) = 1$ for which the error is largest in the far field. Finally, for highly absorbing media, the overall accuracy of the δ - P_1 approximation improves again because the contribution of collimated irradiance to the total light field increases markedly and is well described by the modified Beer-Lambert law of Eq. (7).

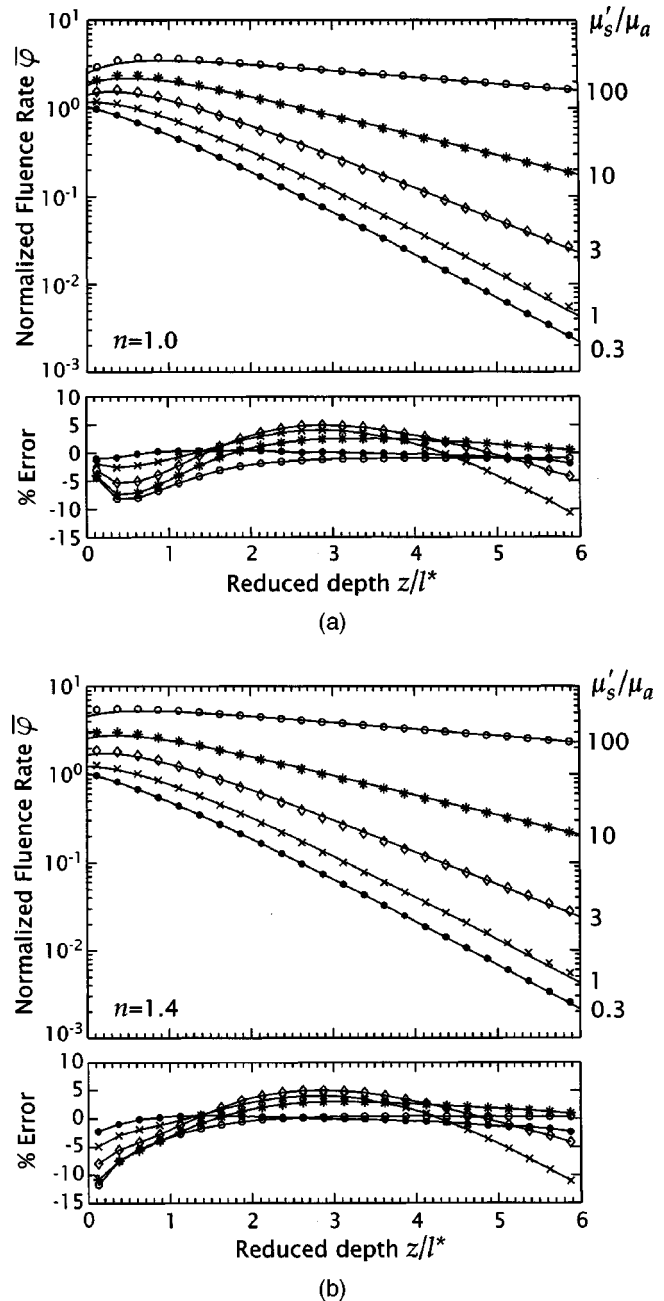


Fig. 3 Normalized fluence rate $\bar{\varphi}$ versus reduced depth (z/l^*) as predicted by the δ - P_1 approximation (solid curves) and Monte Carlo simulations (symbols) for planar illumination under refractive index (a) matched ($n=1.0$) and (b) mismatched ($n=1.4$) conditions. Profiles are shown for $(\mu'_s/\mu_a) = 100$ (\circ), 10 ($*$), 3 (\diamond), 1 (\times), and 0.3 (\bullet) with $g=0.9$. Lower plots show the percentage error of the δ - P_1 predictions relative to the Monte Carlo simulations using the same symbols as the main plot.

In the near field, the accuracy of the δ - P_1 approximation degrades with increasing (μ'_s/μ_a) . The origin of this lies in the fact that increases in scattering result in increased amounts of light backscattered toward the surface. This leads to an increase in the angular asymmetry in the diffuse component of the light field near the surface which is not accurately modeled by a radiance approximation that simply employs a con-

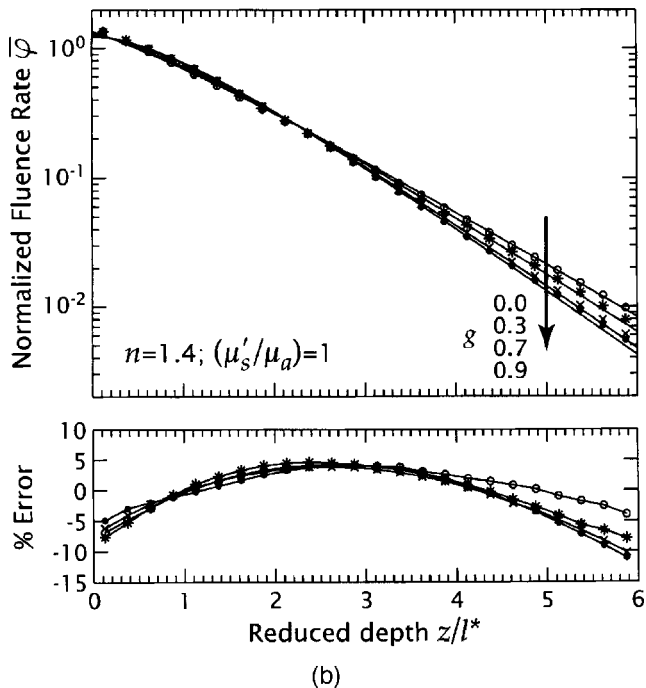
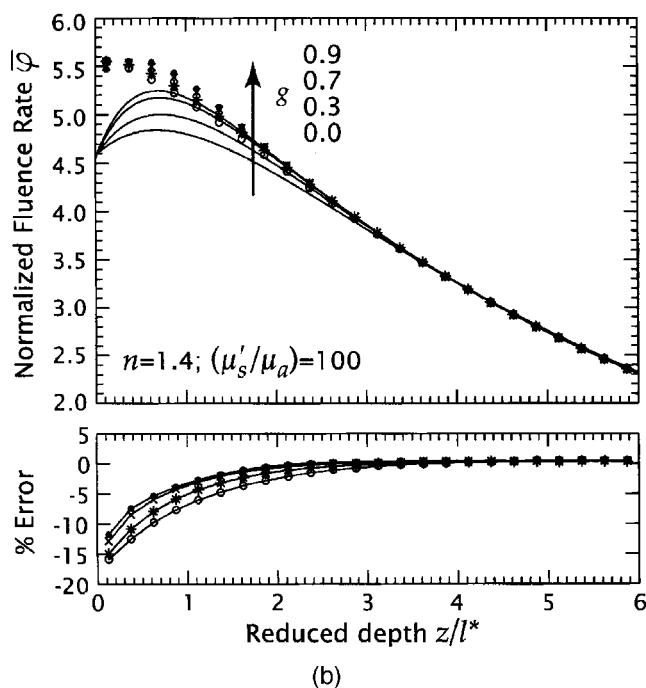
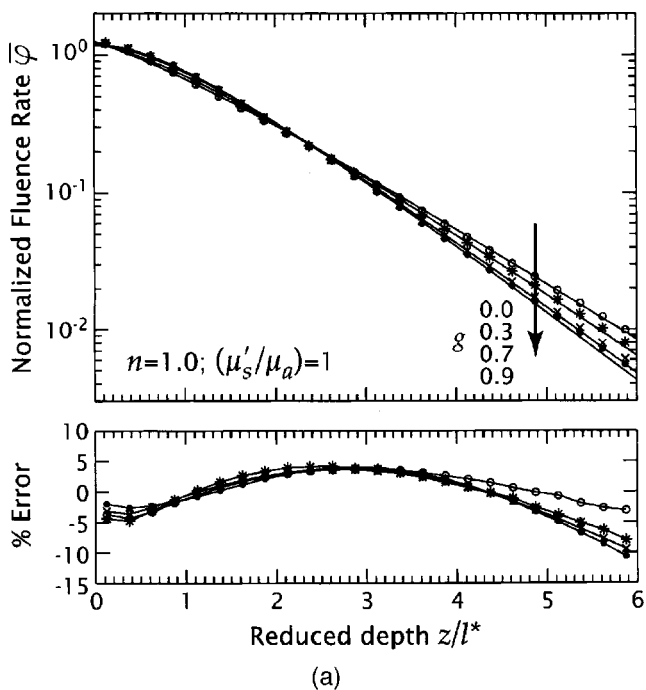
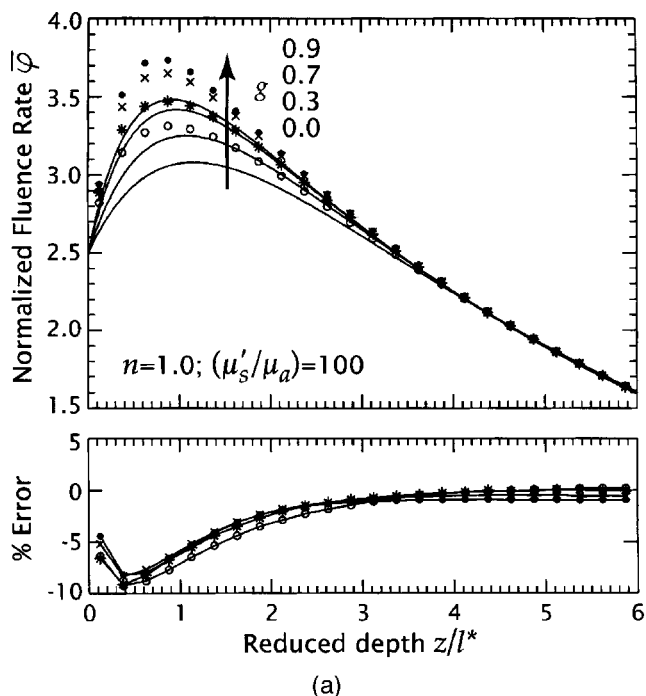


Fig. 4 Normalized fluence rate $\bar{\varphi}$ versus reduced depth (z/l^*) as predicted by the δ - P_1 approximation (solid curves) and Monte Carlo simulations (symbols) for planar illumination under refractive index (a) matched ($n=1.0$) and (b) mismatched ($n=1.4$) conditions. Profiles are shown for $g=0$ (\circ), 0.3 ($*$), 0.7 (\times), and 0.9 (\bullet) with $(\mu'_s/\mu_a) = 100$. Lower plots show the percentage error of the δ - P_1 predictions relative to the Monte Carlo simulations using the same symbols as the main plot.

stant and the first-order Legendre polynomial. The δ - P_1 model performs worse for $n=1.4$ because the refractive index mismatch introduces internal reflection that further enhances the angular asymmetry of the light field near the surface.

However, when scattering is less prominent, the accuracy of the fluence rate profiles is not as strongly dependent on the refractive index mismatch because there is less light backscattered toward the surface.

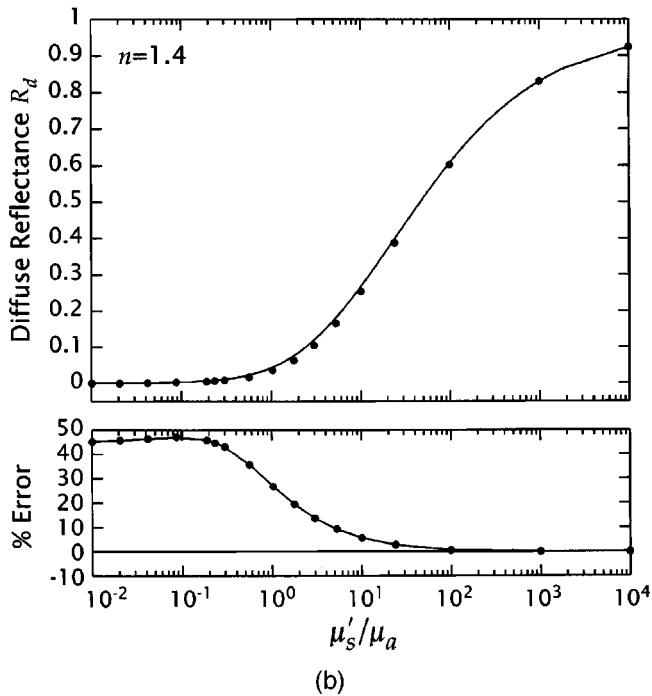
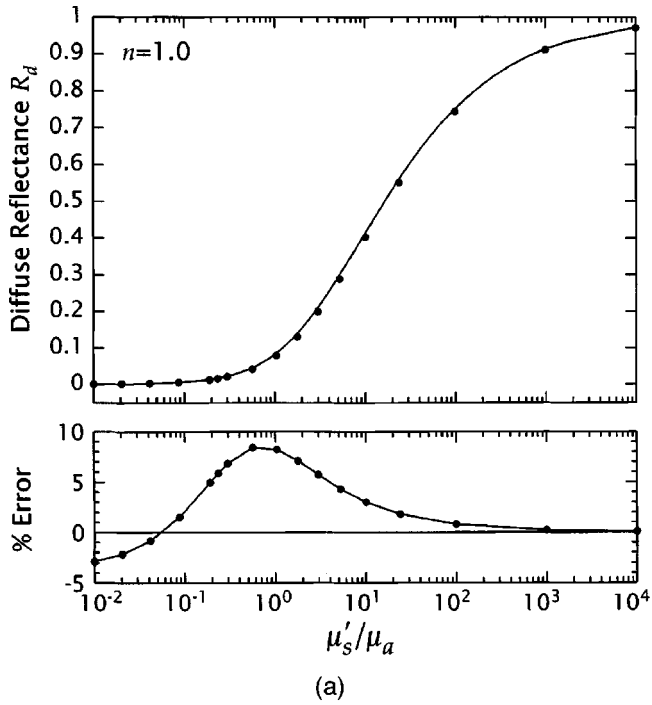


Fig. 6 Diffuse reflectance R_d versus (μ'_s/μ_a) as predicted by the δ - P_1 approximation (solid curves) and MC simulations (●) for planar illumination under refractive index (a) matched ($n=1.0$) and (b) mismatched ($n=1.4$) conditions. Lower plots show the percentage error of the δ - P_1 predictions relative to the MC simulations.

We also examined the influence of the single scattering asymmetry coefficient g on the δ - P_1 model predictions for fixed values of (μ'_s/μ_a) . Figures 4(a) and 4(b) show the variation of the normalized fluence rate profiles for $0 \leq g \leq 0.9$ and $(\mu'_s/\mu_a) = 100$ for $n=1$ and 1.4, respectively. Figures 5(a) and 5(b) show these same results in media with

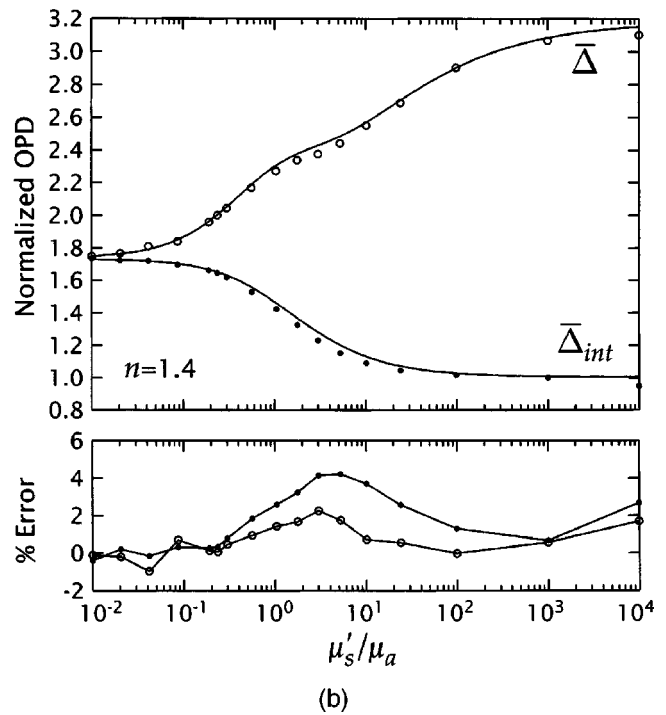
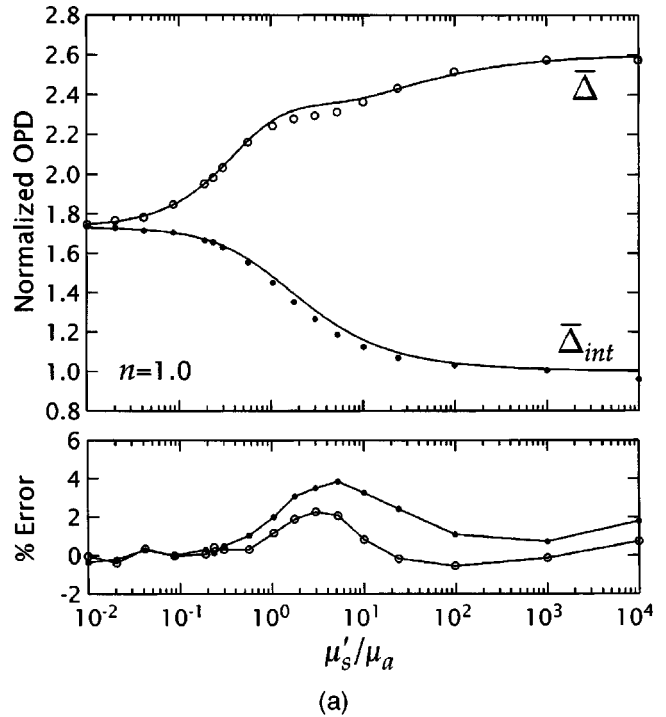


Fig. 7 Normalized optical penetration depths $\bar{\Delta} \equiv \mu_{\text{eff}}\Delta$ (○) and $\bar{\Delta}_{\text{int}} \equiv \mu_{\text{eff}}\Delta_{\text{int}}$ (●) versus (μ'_s/μ_a) as predicted by the δ - P_1 approximation (solid curves) and MC simulations (symbols) for planar illumination under refractive index (a) matched ($n=1.0$) and (b) mismatched ($n=1.4$) conditions. Lower plots show the percentage error of the δ - P_1 predictions relative to the MC simulations.

$(\mu'_s/\mu_a) = 1$. In the highly scattering case, the effect of g is seen most prominently in the near field due to its impact on the boundary condition used in the δ - P_1 approximation. However, the effect is small and results in changes of the error

between δ - P_1 and Monte Carlo (MC) estimates that do not exceed 4% relative to results found for $g=0.9$. Note that for $(\mu'_s/\mu_a)=100$, the value of g does not affect the predictions in the far field as the SDA limit is applicable. As a result the decay of the fluence rate profiles is governed by $\exp(-\mu_{\text{eff}}z)$ and is independent of g for a fixed (μ'_s/μ_a) . By contrast, for $(\mu'_s/\mu_a)=1$, the variation in g affects the errors most prominently in the far field. This occurs because there is minimal backscattering due to the higher absorption in the medium leading to a fluence rate profile whose decay is dependent on g even for a fixed (μ'_s/μ_a) . However, we again see that the effect of g is minimal as the variations in the error are less than 7% even in the far field. Given that these error variations are small and the fact that most soft biological tissues are strongly forward scattering we show all remaining results for a value of $g=0.9$ (Ref. 29).

Figures 6(a) and 6(b) present the variation of the diffuse reflectance R_d with (μ'_s/μ_a) for $n=1.0$ and 1.4, respectively. As in Fig. 3, there is good agreement for large (μ'_s/μ_a) independent of the refractive index mismatch. Under index-matched conditions, there is no internal reflection at the surface and R_d is predicted with a relative error of $\pm 8\%$. For a refractive index mismatch corresponding to a tissue-air interface, the model predictions degrade as (μ'_s/μ_a) is reduced. Specifically, relative errors exceed 15% for $(\mu'_s/\mu_a)<3$. However, as $(\mu'_s/\mu_a)\rightarrow 0$ the model is bound to recover its accuracy since the diffuse component vanishes and $R_d\rightarrow 0$ as $(\mu'_s/\mu_a)\rightarrow 0$. Moreover, for $(\mu'_s/\mu_a)<0.3$ the amount of diffuse reflectance is negligible for all practical purposes. Thus while the relative error in R_d may be large, the absolute error is vanishingly small.

To better characterize the variation in accuracy of the δ - P_1 approximation with (μ'_s/μ_a) we examine the OPDs that characterize the fluence rate profiles. Figures 7(a) and 7(b) present estimates for the normalized OPD metrics $\bar{\Delta}\equiv\mu_{\text{eff}}\Delta$ and $\bar{\Delta}_{\text{int}}\equiv\mu_{\text{eff}}\Delta_{\text{int}}$ as predicted by the δ - P_1 approximation and MC predictions for $10^{-2}\leq(\mu'_s/\mu_a)\leq 10^4$ under refractive index matched ($n=1.0$) and mismatched ($n=1.4$) conditions, respectively.

Note that under conditions of dominant absorption, i.e., $(\mu'_s/\mu_a)\rightarrow 0$, $\mu_{\text{eff}}\rightarrow\sqrt{3}\mu_a$. Thus both $\bar{\Delta}$ and $\bar{\Delta}_{\text{int}}$ approach $(1/\mu_a)(\mu_{\text{eff}})=\sqrt{3}$ as $(\mu'_s/\mu_a)\rightarrow 0$. This result is confirmed in Figs. 7(a) and 7(b). In the limit of high scattering, i.e., $(\mu'_s/\mu_a)\rightarrow\infty$, inspection of Eq. (29) reveals that the value of $\bar{\Delta}$ is dependent on the refractive index mismatch through the boundary parameter A . Setting Eq. (29) equal to $E_0(1-R_s)/e$ and solving we find that $\bar{\Delta}=1+\ln(3+2A)$. Thus, for $(\mu'_s/\mu_a)\rightarrow\infty$, the δ - P_1 approximation predicts that $\bar{\Delta}\rightarrow 2.61$ and 3.19 for $n=1.0$ and 1.4, respectively. By contrast, a similar analysis reveals that $\bar{\Delta}_{\text{int}}$ is not sensitive to the refractive index mismatch and $\bar{\Delta}_{\text{int}}\rightarrow 1$ as $(\mu'_s/\mu_a)\rightarrow\infty$. These asymptotic limits predicted by the δ - P_1 model are confirmed by the results shown in Figs. 7(a) and 7(b). Overall the δ - P_1 predictions for the optical penetration depth are impressive and match the MC estimates to within $\pm 4\%$ over the entire range of (μ'_s/μ_a) . The highest relative errors occur at $(\mu'_s/\mu_a)\approx 1$ as expected from the characteristics of the fluence rate

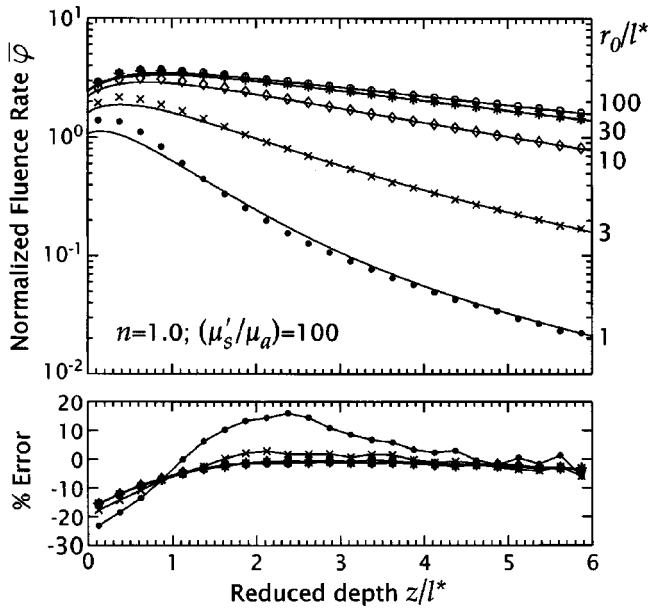
profiles shown in Fig. 3. Better accuracy is observed for $\bar{\Delta}$ ($\pm 2\%$) than for $\bar{\Delta}_{\text{int}}$ ($\pm 4\%$). This is due to the stronger impact that underestimation of the fluence rate near the surface has on the determination of $\bar{\Delta}_{\text{int}}$.

3.2 Gaussian Beam Illumination

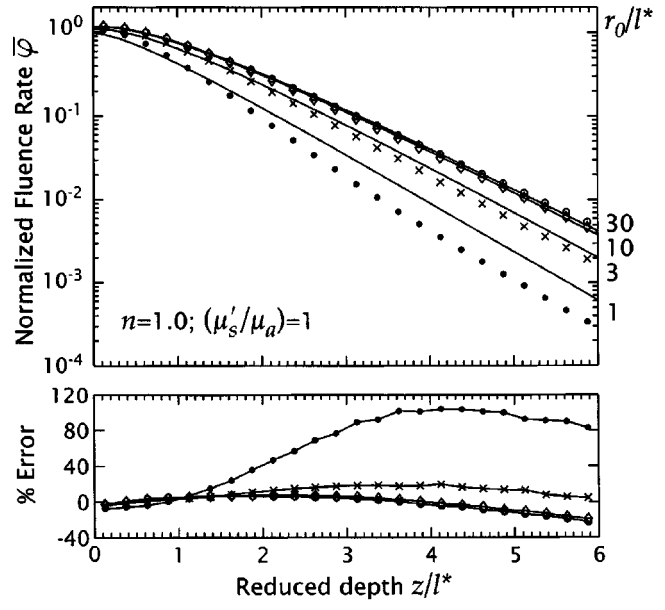
Figures 8(a) and 8(b) provide normalized fluence rate profiles along the beam centerline ($r=0$) as predicted by the δ - P_1 approximation and MC simulations at $(\mu'_s/\mu_a)=100$ for beam radii $r_0=100l^*$, $30l^*$, $10l^*$, $3l^*$, and $1l^*$ with $n=1.0$ and 1.4, respectively. The errors of the δ - P_1 predictions relative to the MC estimates are shown below the main plots. The fluence rate along the beam centerline for $r_0=100l^*$ differs by less than $\pm 0.5\%$ from that produced by planar irradiation. For both $n=1.0$ and 1.4, the δ - P_1 approximation provides good accuracy relative to the MC predictions for beam radii $r_0>3l^*$ ($\pm 17\%$ in the near field, $\pm 5\%$ in the far field). However, the model accuracy degrades for smaller beam radii and reaches $\pm 25\%$ for $r_0=l^*$. This is expected given that the diffusion model breaks down when length scales comparable to l^* are considered.

Figures 9(a) and 9(b) provide results for the more challenging case of $(\mu'_s/\mu_a)=1$. Due to the reduced scattering dispersion that occurs in media of higher absorption, one must consider much smaller beam diameters before the fluence rate profiles along the center differ noticeably from the planar irradiation case. Specifically, for $(\mu'_s/\mu_a)=1$, the fluence rate along the beam centerline for $r_0=30l^*$ differs by less than $\pm 0.5\%$ from that produced by planar irradiation. For $r_0>3l^*$, errors in the fluence rate predictions provided by the δ - P_1 model relative to the MC estimates are $\pm 3\%$ in the near field and $\pm 22\%$ in the far field. However, for $r_0=l^*$, the fluence rate is overestimated by nearly 100% in the far field. While a 100% error may appear striking, one should notice that this occurs once the fluence rate has already dropped by more than two orders of magnitude relative to the surface value. Thus, while the percentage error is large, the error with respect to the overall energy balance is small. This large relative error for small beam radii is not surprising given the great difficulty that low-order functional expansion methods have in modeling the light field when $\mu'_s\approx\mu_a$. In the far field, the accuracy of the δ - P_1 model is nearly independent of the refractive index for the same reasons as those discussed in Sec. 3.1.

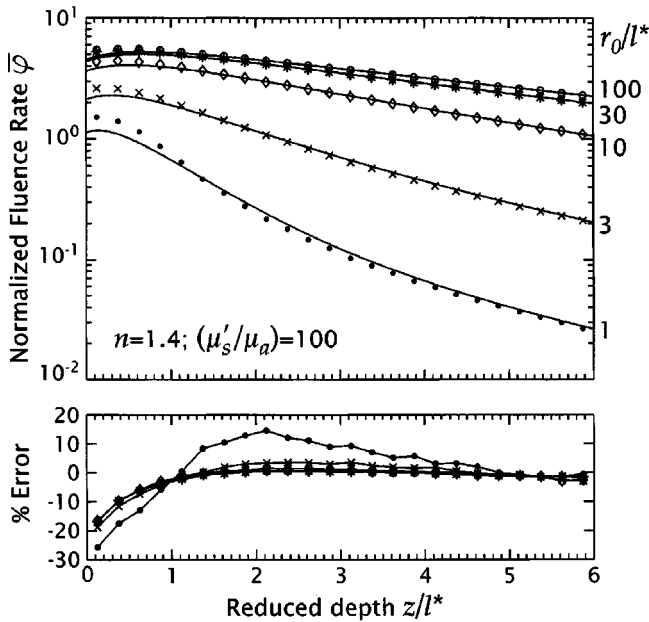
Figures 10(a) and 10(b) provide the normalized OPD $\bar{\Delta}$ along the beam centerline for Gaussian irradiation as predicted by the δ - P_1 model and MC simulations for $10^{-2}\leq(\mu'_s/\mu_a)\leq 10^4$ and beam radii $r_0=1-100l^*$ with $n=1.0$ and 1.4, respectively. Corresponding results for $\bar{\Delta}_{\text{int}}$ are presented similarly in Figs. 11(a) and 11(b). The OPDs determined in the 1-D case are included for comparison as are the corresponding relative errors. The expected limiting behavior for $(\mu'_s/\mu_a)\rightarrow 0$ is identical to that in the planar irradiation case and thus both $\bar{\Delta}$ and $\bar{\Delta}_{\text{int}}$ converge to $\sqrt{3}$. For large (μ'_s/μ_a) the decay of the fluence rate with depth for finite beam illumination occurs on a spatial scale smaller than $\exp(-\mu_{\text{eff}}z)$ because as the incident laser beam propagates in the medium, optical scattering results in significant lateral dis-



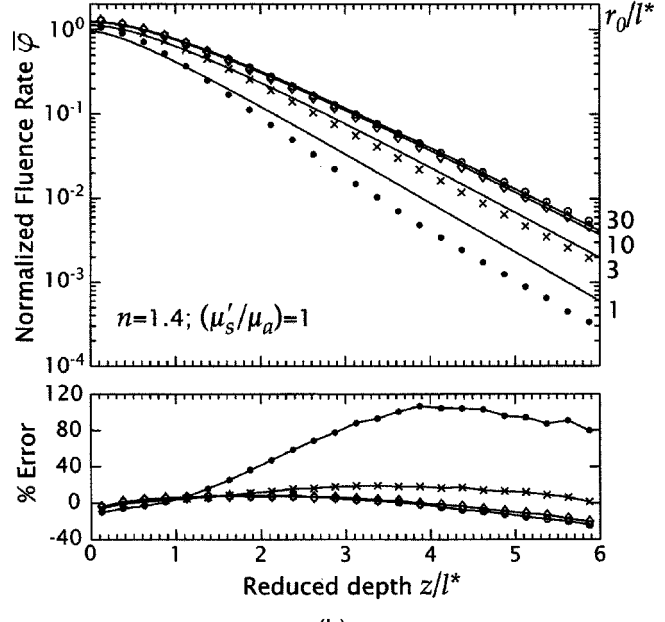

persion from the high fluence region along the beam centerline to the periphery. Thus $\bar{\Delta}$, $\bar{\Delta}_{\text{int}} \rightarrow 0$ as $(\mu'_s/\mu_a) \rightarrow \infty$. The δ - P_1 predictions for $\bar{\Delta}$ and $\bar{\Delta}_{\text{int}}$ track the MC estimates well, with errors of less than $\pm 4\%$ in $\bar{\Delta}$ and $\pm 20\%$ in $\bar{\Delta}_{\text{int}}$ for the smallest beam radius studied ($r_0=l^*$). Once again, the large-

est errors occur for $\mu'_s \approx \mu_a$ and $\bar{\Delta}$ is predicted more accurately than $\bar{\Delta}_{\text{int}}$. Both of these features are consistent with the fluence rate profiles shown in Figs. 8 and 9 where the largest errors are observed close to the surface ($z < 2l^*$) and for $\mu'_s \approx \mu_a$.

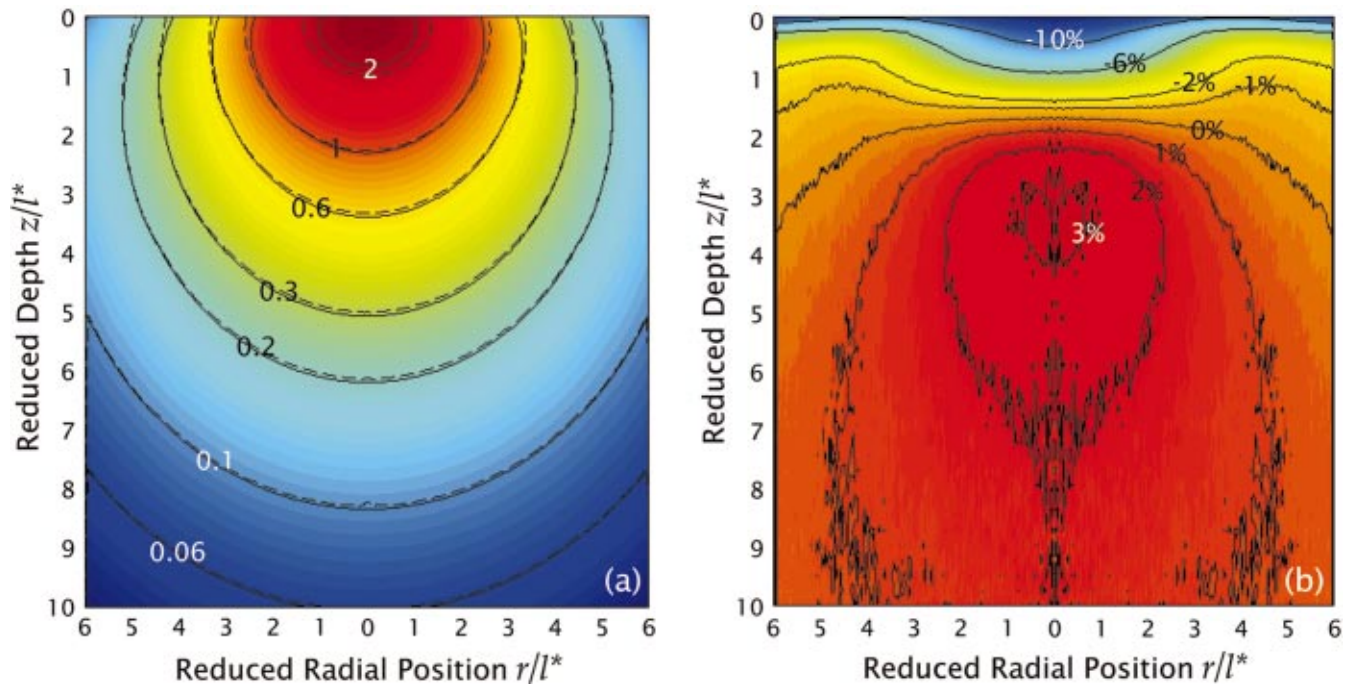


Fig. 12 (a) Color contour plot of the normalized fluence rate $\bar{\varphi}(r, z)$ as predicted by both the δ - P_1 approximation (solid contours and color) and MC simulations (dashed contours) for Gaussian beam irradiation with $r_0=3l^*$ in media with $(\mu_s'/\mu_a)=100$ for $g=0.9$ under refractive index mismatched conditions ($n=1.4$); and (b) relative error between δ - P_1 approximation and MC simulations.

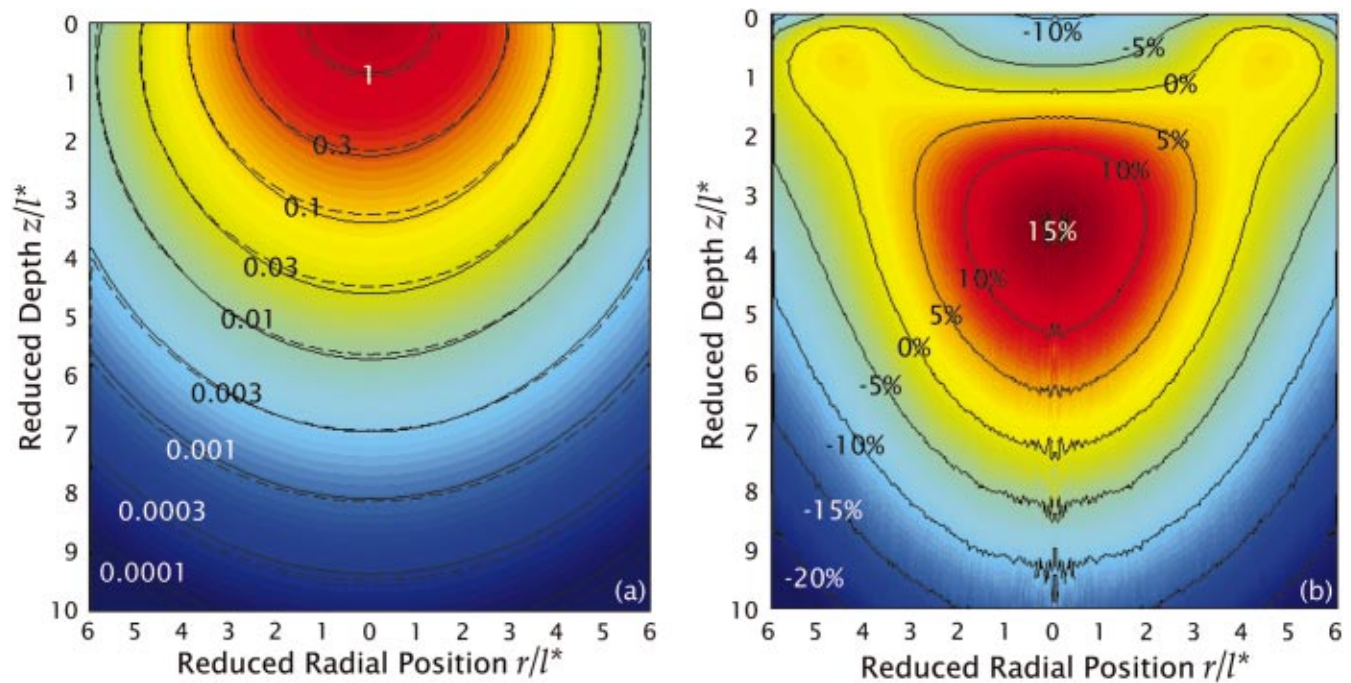


Fig. 13 (a) Color contour plot of the normalized fluence rate $\bar{\varphi}(r, z)$ as predicted by both the δ - P_1 approximation (solid contours and color) and MC simulations (dashed contours) for Gaussian beam irradiation with $r_0=3l^*$ in media with $(\mu_s'/\mu_a)=3$ for $g=0.9$ under refractive index mismatched conditions ($n=1.4$); and (b) relative error between δ - P_1 approximation and MC simulations.

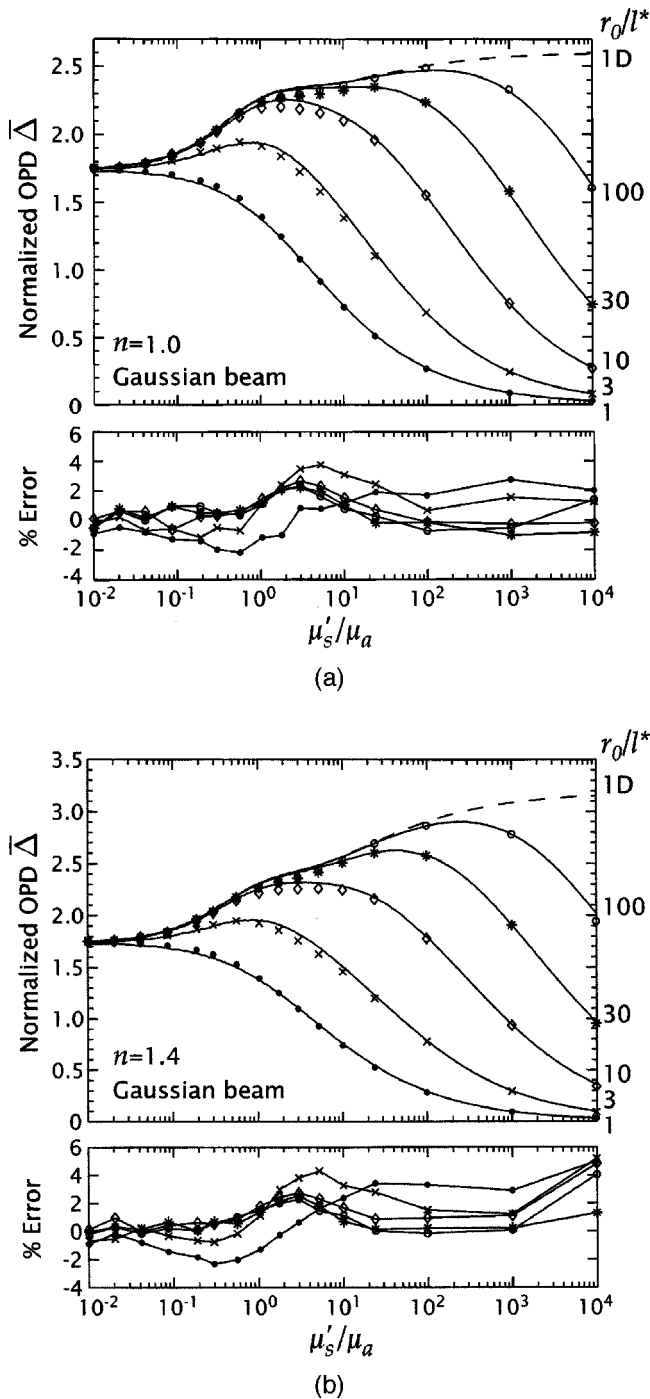


Fig. 10 Normalized optical penetration depth $\bar{\Delta}$ versus (μ'_s/μ_a) as predicted by the δ - P_1 approximation (solid curves) and MC simulations (symbols) along the beam centerline for Gaussian illumination for $g=0.9$ with $r_0=100l^*$ (\circ), $30l^*$ ($*$), $10l^*$ (\diamond), $3l^*$ (\times), and $1l^*$ (\bullet) under refractive index (a) matched ($n=1.0$) and (b) mismatched ($n=1.4$) conditions. The optical penetration depth for planar illumination predicted by the δ - P_1 approximation is plotted as a dashed curve. Lower plots show the percentage error of the δ - P_1 predictions relative to the MC simulations.

Figure 12(a) provides a color contour plot representing the 2-D fluence rate distribution for a Gaussian beam of radius $r_0=3l^*$ with $(\mu'_s/\mu_a)=100$ and $n=1.4$. The solid isofluence rate contours and the color map correspond to the prediction

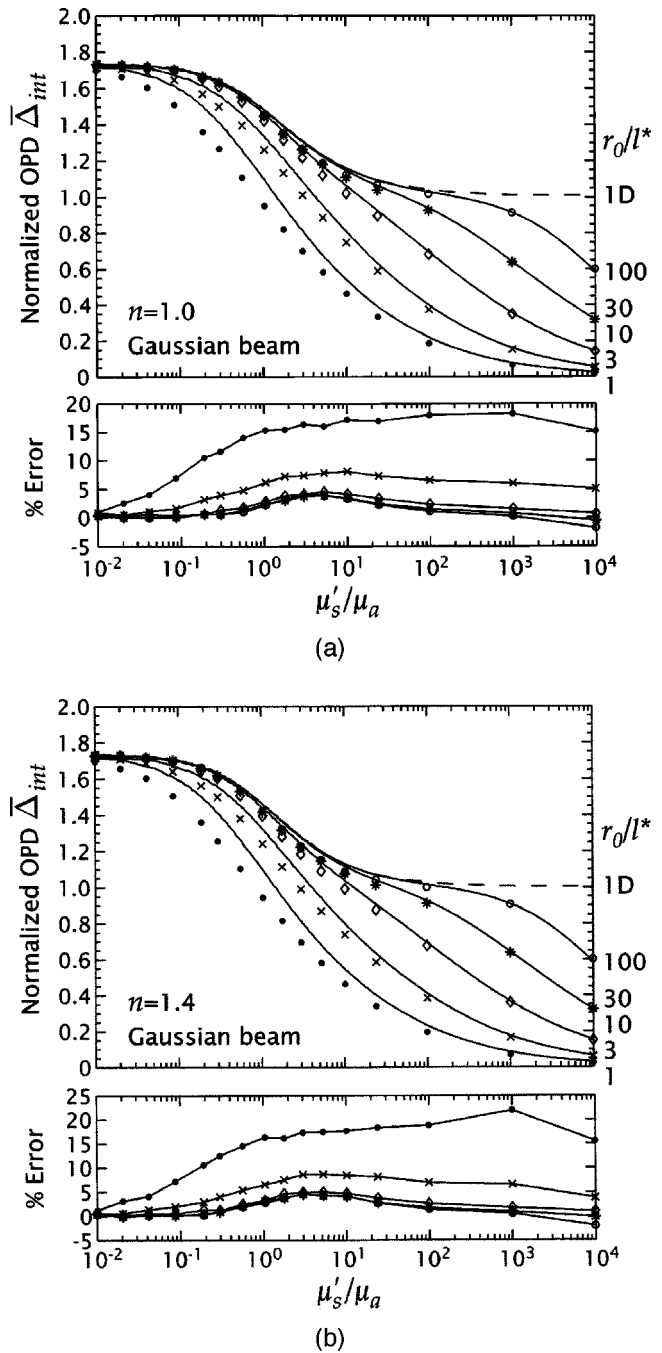


Fig. 11 Normalized optical penetration depth $\bar{\Delta}_{int}$ versus (μ'_s/μ_a) as predicted by the δ - P_1 approximation (solid curves) and MC simulations (symbols) along the beam centerline for Gaussian illumination for $g=0.9$ with $r_0=100l^*$ (\circ), $30l^*$ ($*$), $10l^*$ (\diamond), $3l^*$ (\times), and $1l^*$ (\bullet) under refractive index (a) matched ($n=1.0$) and (b) mismatched ($n=1.4$) conditions. The optical penetration depth for planar illumination predicted by the δ - P_1 approximation is plotted as a dashed line. Lower plots show the percentage error of the δ - P_1 predictions relative to the MC simulations.

provided by the δ - P_1 approximation while the dashed isofluence rate contours represent predictions given by the MC simulations. Figure 12(b) provides the 2-D distribution of the relative errors between the δ - P_1 predictions and the MC simulations. Thus, the δ - P_1 and MC contours shown in Fig.

12(a) provides some indication of the errors in penetration depth that one makes when using the δ - P_1 approximation, while Fig. 12(b) provides the errors in the actual optical dosimetry.

The quality of the δ - P_1 predictions are excellent; the error in the fluence rate relative to the MC estimates never exceeds 20% and is less than 10% over the vast majority of the domain. In the axial direction, the maximum errors occur in the near field close to the boundary, while in the radial direction, they occur along the beam centerline. This is expected because it is at these locations where the spatial gradients and angular asymmetry of the light field are greatest. Figures 13(a) and 13(b) provide plots under identical irradiation conditions for a turbid medium with $(\mu'_s/\mu_a)=3$. In Fig. 13(a) we see similar errors in the location of the isofluence rate contours when comparing the δ - P_1 approximation relative to the MC predictions. However, in Fig. 13(b), we observe a different spatial pattern and magnitude of the fluence rate errors incurred when using the δ - P_1 approximation rather than a MC estimate. As in Fig. 12(b), the maximum errors in the radial direction occur along the beam centerline. However, in the axial direction, the maximum errors reside in the far field and appear to be increasing with depth. This is similar to the planar irradiation case and occurs because the spatial scale for the decay of the fluence rate with depth lies between $\exp(-\mu_{\text{eff}}z)$ and $\exp(-\mu'_t z)$; thereby leading to poor predictions by the δ - P_1 approximation in the far field under these conditions. It is important to note that examination of δ - P_1 predictions at radial locations away from the centerline reveals equivalent, if not better, accuracy in both fluence rate profiles and OPD metrics. For example, for Gaussian beam radii $r_0 > 3l^*$, the errors in both $\bar{\Delta}$ and $\bar{\Delta}_{\text{int}}$ at the radial location $r=r_0$ are ≤ 5 and $\leq 8\%$, respectively, over the full range of (μ'_s/μ_a) . This result is consistent with the errors of the full fluence rate distributions shown in Figs. 12 and 13.

3.3 Gaussian Beam versus Planar Irradiation Treatment

As is evident from the results, the use of laser beams of small diameter significantly alters the fluence rate profile and optical penetration depth. For example, Gaussian irradiation of a medium with $(\mu'_s/\mu_a)=100$ using a beam radius of $r_0=3l^*$ results in a fluence rate that is only $\sim 50\%$ of that achieved using planar illumination. Moreover, the reduction in both fluence rate and OPD for decreasing beam diameters is more prominent in media with large (μ'_s/μ_a) because the scattering enhances lateral dispersion of the collimated radiation (Figs. 8–13). However, the Gaussian beam expressions are a bit more formidable than those for the case of planar irradiation. As a result, for simplicity and convenience, it may be useful to determine the conditions under which the results of a planar irradiation analysis provides sufficiently accurate predictions along the centerline of a Gaussian beam. This may obviate the need to use the more complex expressions corresponding to Gaussian beam irradiation in some cases.

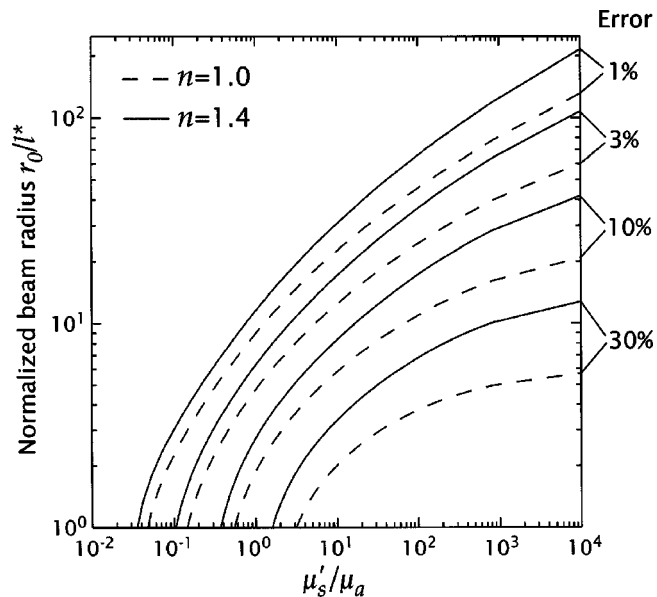


Fig. 14 Contours for the error incurred in predicting fluence rate profiles along the centerline of a Gaussian laser beam of normalized radius r_0/l^* as a function of (μ'_s/μ_a) when using δ - P_1 predictions for the planar irradiation case for $n=1.0$ (dashed) and $n=1.4$ (solid).

Figure 14 provides these results in the form of a contour plot showing the percentage difference between the fluence rate predictions given by the δ - P_1 approximation for Gaussian beam irradiation along the centerline compared to planar irradiation as a function of both normalized beam radius

(r_0/l^*) and optical properties (μ'_s/μ_a) . Contours are provided for differences of 1, 3, 10, and 30% for $n=1.0$ (solid contours) and 1.4 (dashed contours), respectively. These results indicate that as absorption becomes more dominant, the centerline fluence rate profiles produced by laser beams of smaller diameter can be adequately approximated using the planar irradiation predictions. This can also be seen in the OPD results shown earlier in Figs. 10 and 11. In these figures, we observed that for a given beam radius, there is a certain value of (μ'_s/μ_a) above which the OPDs corresponding to Gaussian irradiation drop below the OPDs for planar irradiation. We note that this value of (μ'_s/μ_a) becomes lower as smaller beam diameters are used. Note also that the inaccuracies incurred in using the planar irradiation results are always lower for the index-matched case. This is because the presence of a refractive index mismatch results in internal reflection at the tissue-air interface that enhances lateral dispersion of the light field. This additional source of dispersion hastens the need for the use of a radiative transport model that is geometrically faithful to the irradiation conditions.

4 Conclusion

We have shown that the δ - P_1 approximation to the Boltzmann transport equation provides remarkably accurate predictions of light distribution and energy deposition in homogeneous turbid semi-infinite media. Examination of the functional expressions involved in the δ - P_1 approximation reveals proper asymptotic behavior in the limits of absorption- and scattering-dominant media. Comparison of the fluence rate and optical penetration depth predictions given by the δ - P_1 approximation with MC simulations demonstrate the greater fidelity and accuracy of the δ - P_1 model relative to the standard diffusion approximation.

The availability of an analytic light transport model providing accurate optical dosimetry predictions is an invaluable tool for the biomedical optics community. By providing our results in terms of dimensionless quantities, they can be used to rapidly estimate the fluence rate distributions and optical penetration depths generated by a wide range of irradiation conditions and tissue optical properties. Thus beyond a greater theoretical understanding of the significant gains to be realized through the use of the δ - P_1 approximation over the standard diffusion approximation, these figures provide the biomedical optics community with charts that can be used for rapid lookup and estimation of light-transport related quantities.

5 Appendix A Derivation of Surface Boundary Conditions in the δ - P_1 Approximation

The governing equations of the δ - P_1 approximation are (see Sec. 2):

$$\nabla^2 \varphi_d(\mathbf{r}) - 3\mu_a \mu_{tr} \varphi_d(\mathbf{r}) = -3\mu_s^* \mu_{tr} E(\mathbf{r}, \hat{z}) + 3g^* \mu_s^* \nabla E(\mathbf{r}, \hat{z}) \cdot \hat{z} \quad (31)$$

$$\mathbf{j}(\mathbf{r}) = -\frac{1}{3\mu_{tr}} [\nabla \varphi_d(\mathbf{r}) - 3g^* \mu_s^* E(\mathbf{r}, \hat{z}) \hat{z}], \quad (32)$$

where \mathbf{r} is the position in the medium, \hat{z} is the unit vector colinear with the direction of the collimated source, $E(\mathbf{r}, \hat{z})$ is the irradiance distribution of the collimated source, μ_a is the absorption coefficient, $\mu_{tr} \equiv \mu_a + \mu_s'$ is the transport coefficient with μ_s' being the isotropic scattering coefficient, g^* is the single scattering asymmetry coefficient of the P_1 portion of the δ - P_1 phase function, and $\mu_s^* \equiv \mu_s(1-f)$ is a reduced scattering coefficient. Selection of f and g^* depends on the selection of the phase function as described in Sec. 2.1.

Two boundary conditions are required to solve Eq. (31). Requiring conservation of the diffuse flux component normal to the interface, we obtain^{6,23}

$$\int_{\hat{\omega} \cdot \hat{z} \geq 0} L_d(\mathbf{r}, \hat{\omega})(\hat{\omega} \cdot \hat{z}) d\hat{\omega} = \int_{\hat{\omega} \cdot \hat{z} < 0} L_d(\mathbf{r}, \hat{\omega}) r_F(-\hat{\omega} \cdot \hat{z})(-\hat{\omega} \cdot \hat{z}) d\hat{\omega}, \quad (33)$$

where \hat{z} is the inward-pointing surface normal, and $r_F(-\hat{\omega} \cdot \hat{z})$ is the Fresnel reflection coefficient for unpolarized light. The preceding condition can be described in words as equating the amount of diffuse light that travels upward ($\hat{\omega} \cdot \hat{z} < 0$) and gets internally reflected at the interface with the amount of diffuse light traveling downward ($\hat{\omega} \cdot \hat{z} \geq 0$) from the interface.

Substituting the approximation for the diffuse fluence rate given by Eq. (9) and using Eq. (32) to eliminate $\mathbf{j}(\mathbf{r})$, we obtain the following form for the surface boundary condition in the δ - P_1 approximation:

$$[\varphi_d(\mathbf{r}) - Ah \nabla \varphi_d(\mathbf{r}) \cdot \hat{z}]|_{z=0} = -3Ahg^* \mu_s^* E(\mathbf{r}, \hat{z})|_{z=0}, \quad (34)$$

where $A = (1 + R_2)/(1 - R_1)$ and $h = 2/3\mu_{tr}$. This result is identical to that provided by Eq. (12). Here R_1 and R_2 are the first and second moments of the Fresnel reflection coefficient for unpolarized light, as given by Eq. (13).

Note that in many implementations of the SDA, A is approximated instead by $A \approx (1 + R_1)/(1 - R_1)$. While this is strictly incorrect, it results in slightly better approximations of the fluence rate in the near field at the expense of providing worse fluence rate approximations in the far field as well as violating conservation of energy when integrating the light field over the entire volume. The following cubic polynomial provides an estimate for $A = (1 + R_2)/(1 - R_1)$ that typically differs from the exact value by less than 1%:²³

$$A(n) = -0.13755n^3 + 4.3390n^2 - 4.90366n + 1.6896. \quad (35)$$

6 Appendix B Solution of the δ - P_1 Approximation for Planar Illumination of a Semi-Infinite Medium

For planar illumination the source term is given by

$$E(z, \hat{\omega}) = E_0(1 - R_s) \exp(-\mu_t^* z) \delta(1 - \hat{\omega} \cdot \hat{z}), \quad (36)$$

where E_0 is the irradiance, $\hat{\omega}$ is the unit direction vector, and \hat{z} is the inward pointing unit vector normal to the surface of the medium and is colinear with the z coordinate axis. Substituting Eq. (36) into Eq. (10), we obtain the governing equation for a planar geometry:

$$\frac{d^2 \varphi_d(z)}{dz^2} - 3\mu_a \mu_{tr} \varphi_d(z) = -3\mu_s^* (\mu_t^* + g^* \mu_a) E_0(1 - R_s) \exp(-\mu_t^* z). \quad (37)$$

The boundary conditions for the 1-D case reduce to

$$\left(\varphi_d - Ah \frac{d\varphi_d(z)}{dz} \right) \Big|_{z=0} = -3Ahg^* \mu_s^* E_0(1 - R_s), \quad (38)$$

$$\varphi_d(z) \Big|_{z \rightarrow \infty} \rightarrow 0. \quad (39)$$

The solution to Eq. (37) satisfying the Eqs. (38) and (39) is

$$\varphi_d(z) = E_0(1 - R_s) [\alpha \exp(-\mu_t^* z) + \beta \exp(-\mu_{\text{eff}} z)], \quad (40)$$

where

$$\alpha = \frac{3\mu_s^* (\mu_t^* + g^* \mu_a)}{\mu_{\text{eff}}^2 - \mu_t^{*2}} \quad (41)$$

and

$$\beta = \frac{-\alpha(1 + Ah\mu_t^*) - 3Ahg^* \mu_s^*}{(1 + Ah\mu_{\text{eff}})}. \quad (42)$$

These results are identical to that provided by Eqs. (18) to (20).

7 Appendix C Solution of the δ - P_1 Approximation for Gaussian Beam Illumination of a Semi-Infinite Medium

The source term for a Gaussian beam profile is given by

$$E(r, z) = E_0(1 - R_s) \exp(-\mu_t^* z) \exp\left(-\frac{2r^2}{r_0^2}\right), \quad (43)$$

where r_0 is the $1/e^2$ beam radius, and $E_0 = 2P/(\pi r_0^2)$, where P is the power of the laser beam. The governing equation in cylindrical coordinates has the form

$$\begin{aligned} \frac{1}{r} \frac{\partial}{\partial r} \left(r \frac{\partial \varphi_d(r, z)}{\partial r} \right) + \frac{\partial^2 \varphi_d(r, z)}{\partial z^2} - \mu_{\text{eff}}^2 \varphi_d(r, z) \\ = -3\mu_s^* (\mu_t^* + g^* \mu_s^*) E(r, z), \end{aligned} \quad (44)$$

subject to the boundary conditions:

$$\left(\varphi_d - Ah \frac{\partial \varphi_d}{\partial z} \right) \Big|_{z=0} = -3Ahg^* \mu_s^* E(r, z) \Big|_{z=0}, \quad (45)$$

$$\frac{\partial \varphi_d(r, z)}{\partial r} \Big|_{r=0} = 0, \quad (46)$$

$$\varphi_d(r, z) \Big|_{z \rightarrow \infty} \rightarrow 0, \quad (47)$$

$$\varphi_d(r, z) \Big|_{r \rightarrow \infty} \rightarrow 0. \quad (48)$$

The solution procedure begins by assuming that both $\varphi_d(r, z)$ and the right-hand side of Eq. (44) can be written as Hankel transforms of two functions $f(k, z)$ and $u(k, z)$, respectively, i.e.,

$$\int_0^\infty f(k, z) \mathcal{J}_0(kr) k dk = \varphi_d(r, z) \quad (49)$$

and

$$\begin{aligned} \int_0^\infty u(k, z) \mathcal{J}_0(kr) k dk = -3\mu_s^* (\mu_t^* + g^* \mu_a) E_0(1 - R_s) \\ \times \exp(-\mu_t^* z) \exp\left(-\frac{2r^2}{r_0^2}\right), \end{aligned} \quad (50)$$

where \mathcal{J}_0 is the zeroth-order Bessel function of the first kind. Substituting Eqs. (49) and (50) into Eq. (44) we obtain

$$\begin{aligned} \frac{1}{r} \frac{\partial}{\partial r} \left[r \frac{\partial}{\partial r} \int_0^\infty f(k, z) \mathcal{J}_0(kr) k dk \right] \\ + \frac{\partial^2}{\partial z^2} \int_0^\infty f(k, z) \mathcal{J}_0(kr) k dk \\ - \mu_{\text{eff}}^2 \int_0^\infty f(k, z) \mathcal{J}_0(kr) k dk = \int_0^\infty u(k, z) \mathcal{J}_0(kr) k dk. \end{aligned} \quad (51)$$

We note that the first term of Eq. (51) appears in the Bessel's equation:

$$-\frac{1}{r} \frac{\partial}{\partial r} r \frac{\partial}{\partial r} \mathcal{J}_0(kr) + k^2 \mathcal{J}_0(kr) = 0, \quad (52)$$

for which \mathcal{J}_0 is a solution. Thus Eq. (51) can be rewritten by adding and subtracting $k^2 \mathcal{J}_0(kr)$ on the left-hand side of Eq. (52), which yields

$$\begin{aligned} \int_0^\infty (-k^2 - \mu_{\text{eff}}^2) f(k, z) \mathcal{J}_0(kr) k dk \\ + \int_0^\infty \frac{\partial^2}{\partial z^2} \mathcal{J}_0(kr) f(k, z) k dk \\ = \int_0^\infty u(k, z) \mathcal{J}_0(kr) k dk. \end{aligned} \quad (53)$$

Using a table of Hankel transforms,³³ $u(k, z)$ can be chosen such that Eq. (50) is satisfied, namely,

$$\begin{aligned} \frac{\partial^2}{\partial z^2} f(k, z) - (k^2 + \mu_{\text{eff}}^2) f(k, z) \\ = -3\mu_s^* (\mu_t^* + g^* \mu_a) E_0(1 - R_s) \frac{r_0^2}{4} \\ \times \exp\left(-\frac{r_0^2 k^2}{8}\right) \exp(-\mu_t^* z). \end{aligned} \quad (54)$$

The boundary conditions in (k, z) space are obtained through Hankel transformation of Eqs. (45) to (48):

$$\begin{aligned} \left[\frac{\partial}{\partial z} f(k, z) - \frac{1}{Ah} f(k, z) \right] \Big|_{z=0} = \frac{3}{4} g^* \mu_s^* E_0(1 - R_s) r_0^2 \\ \times \exp\left(-\frac{r_0^2 k^2}{8}\right), \end{aligned} \quad (55)$$

and

$$f(k, z) \Big|_{z \rightarrow \infty} \rightarrow 0. \quad (56)$$

Solving the Eq. (54) for $f(k, z)$ and substitution of the results into Eq. (49) gives the following form for $\varphi_d(r, z)$:

$$\begin{aligned} \varphi_d(r, z) = E_0(1 - R_s) \int_0^\infty \{ \gamma \exp(-\mu_t^* z) \\ + \xi \exp[-(k^2 + \mu_{\text{eff}}^2)^{1/2} z] \} \mathcal{J}_0(kr) k dk, \end{aligned} \quad (57)$$

where

$$\gamma = \frac{3\mu_s^* (\mu_t^* + g^* \mu_a) r_0^2 \exp(-r_0^2 k^2 / 8)}{4(k^2 + \mu_{\text{eff}}^2 - \mu_t^*)} \quad (58)$$

and

$$\xi = \frac{-3g^* \mu_s^* r_0^2 \exp(-r_0^2 k^2 / 8) - 4\gamma[(Ah)^{-1} + \mu_t^*]}{4[(Ah)^{-1} + (k^2 + \mu_{\text{eff}}^2)^{1/2}]}. \quad (59)$$

These results are identical to that provided by Eqs. (22) to (24).
